## ***Terms & Conditions...Contract Accounts***

1. A 25% Deposit of the total booking price is required with this signed contract. The Deposit balance will be deducted from the final contract invoice.
2. Rentals of three occasions or less are payable in full at the time of submitting the Contract. Cancellations are subject to penalty (see 6).
3. A signed Contract confirms that you understand and accept the terms and conditions therein, including financial obligations to the Club. Co-signers are responsible for the obligations if defaulted by the Principal.
4. A Monthly Invoice will be sent to the Organization at the address listed above. It is the Organization's responsibility to inform the Club of address or contact changes.
5. Account balances are due before the 15<sup>th</sup> day of the Month following the Invoice date. Bookings for accounts that are not current will be cancelled and subject to penalty (see 6). Interest may be charged on outstanding balances.
6. Cancellation of a rental date without penalty requires two weeks' notice in writing to the Club. Cancellations received eight (8) to fourteen (14) days before the rental date will be invoiced at half the regular booking rate. Cancellations received within seven (7) days of the rental date will be invoiced the full amount. A rental may be cancelled at no charge on the day of the event if the Manitoba Department of Highways has closed Highways 75 or 59 in the vicinity of St. Adolphe, or if they have indicated that "travel is not advised" on Highways 75 or 59 in the vicinity of St. Adolphe.
7. The cost to rectify any damage or excessive cleaning attributed to the negligence of the contracted organization will be added to the rental agreement. Bookings are cancelled until full outstanding payment is made.
8. Bookings include occupation of one team Dressing Room for ½-hour before and after the scheduled ice time. Dressing Room assignment is at the discretion of the Facility Manager. Exceptions must be noted on this Contract.
9. Failure to comply with the terms and conditions of this Contract will render it void and cancels the ice reservation. This cancelled booking may result in invoicing at half the regular rate, at the discretion of the Club Executive.
